**Welcome to your seaside break. Please take a moment to read our booking conditions and noise policy below as we want to ensure that all our guests have a wonderful stay and that our neighbours are not disturbed.**

## Booking Terms & Conditions

**Payment.** A deposit of £500 is payable if the booking is made more than 8 weeks before the start of the rental. The balance shall be payable 8 weeks before the commencement of the rental. Yellowstones beach house will construe non-payment of the balance of the rental fee on or before the due date as cancellation of the rental by the client. For bookings made less than 8 weeks before the commencement of the rental the total fee is payable on booking. Any breach of terms and conditions may result in deposit being kept in part or full.

**Cancellation.** Any cancellation by the client should be made in writing to the above address. On receipt of the notice of cancellation, Yellowstones beach house will seek to re-let the property for the period of the booking. If Yellowstones beach house succeeds in re-letting the property for the whole period it shall refund all monies paid less a £20 administrative charge. If Yellowstones beach house only succeeds in re-letting the property for part of the period booked it shall refund an amount equal to the money paid less the rental for the period which is not re-let and less a £20 administrative charge. If Yellowstones beach house is not able to re-let the property at all for the period then all monies paid by the client shall be forfeit to Yellowstones beach house. We recommend that you arrange Insurance to cover the booking.

**Changes of Date.** Yellowstones beach house may consider a request from a client to change the dates of the booking after confirmation has been issued. However, there is no guarantee that requests can be accommodated.

**Period of Rental.** Rentals commence at 4 p.m. on the day of arrival and terminate at 10 a.m. on the day of departure, unless otherwise agreed.

**Use of Property.** The number of persons occupying the property must not exceed the number stipulated in the booking, unless agreed otherwise. The property will be used for personal and domestic purposes only. The property shall not be used for any commercial purposes without the written consent of Yellowstones beach house. In order to ensure the peace and quiet of our neighbours, music or other noise that can be heard outside the property is not permitted after 9 pm. Yellowstones beach house reserves the right to refuse entry to the entire party if these conditions are not observed. A full list of the guests Names and Ages must be provided with the return of the signed booking terms and conditions.

**Holiday Accommodation.** Yellowstones beach house is let as holiday accommodation and does not create a Landlord and Tenant relationship within the meaning of the Rent acts.

**Complaints.** Should there be cause for complaint during the rental of the property, it must be notified promptly to Yellowstones beach house.

**Breakages or Damage.** The client is legally bound to reimburse Yellowstones beach house for replacement, repair or extra cleaning costs on demand. We do not charge for minor breakages only for serious or wilful damage. In the unlikely event of serious damage, Yellowstones beach house does not limit its claim to the damage deposit, but would seek full compensation.

**Care of the Property.** The client shall take all reasonable and proper care of the property and its furniture, pictures, fittings and effects in or on the property and leave them in the same state of repair and in the same clean and tidy condition at the end of the rental period as at the beginning. An additional charge may be made if extra cleaning is required. Yellowstones beach house will check the condition and contents of the property and will notify the hirer within fourteen days of any additional cleaning costs or charges for damage and breakages for which the hirer is liable. Payment shall be made by the hirer immediately on receipt of the invoice in respect of the above charges. The charges will be deducted from the terms and conditions deposit and the balance refunded to the hirer by Yellowstones beach house within fourteen days.

**Group bookings.** Unless otherwise agreed in writing between Yellowstones beach house and the hirer, no more than the maximum of persons as stated on the website and/ or brochure may occupy the property. Admittance may be refused if this condition is not observed. Yellowstones beach house reserves the right to refuse or revoke bookings from parties which may in their opinion be unsuitable for the property concerned. In such cases all payments made will be refunded in full and the contract will be discharged.

**Pets.** Dogs are welcome on prior arrangement with Yellowstones beach house. Dogs must be kept under proper supervision and control at all times and must be kept on the ground floor only. No pets other than dogs are permitted.

**Smoking.** Smoking is not permitted in Yellowstones beach house. Smoking outdoors is only permitted outside the games room, please ensure that you use ash trays provided. No candles are to be lit in or outside the house or property at any time due to being a high fire risk.

**Liability.** Yellowstones beach house (for itself, its employees and agents) shall not be liable to the client for any accident, damage, loss, injury, expense or inconvenience, which may be suffered, incurred, arise out of or in any way connected with the rental. If the property becomes unavailable or unusable for some reason prior to the commencement of the rental, then Yellowstones beach houses' obligation will be to reimburse the client for any monies paid.

**Right of Entry.** Yellowstones beach house shall be allowed the right of entry to the property at all reasonable times for purposes of inspection or to carry out any necessary repairs or maintenance. For weekly rentals Yellowstones beach house will require access to clean the property once during the rental.

**Termination of booking.** The right is reserved to terminate the booking with immediate effect if the hirer fails to observe the rules imposed from time to time by Yellowstones beach house and in the event of termination under the provisions of this clause the hirer will not be entitled to any refund of the hiring fee paid. The rules are set out in the schedule hereto and Yellowstones beach house reserves the right to alter, amend or add to the rules and conditions at any time.

**Noise Policy.** Yellowstones beach house has a private setting but we do have neighbours whose needs we respect. We therefore ask all our guests to show consideration to the environment and our neighbours in all matters, and especially with regard to noise. To help ensure everyone's holiday goes well, we ask you to respect the following noise rules:

After **9pm** and before **9am** please use the gardens around the house as quiet areas

- Please do not take radios, CD players or other sources of music outside the house.
- Please limit any music playing or television noise inside the house so it cannot be heard outside.
- Please do not turn up music within the property to provide music outside
- Please show consideration for our neighbours in the early morning and late evening

**Surveillance & CCTV .** In the public outside areas of the Yellowstones beach house CCTV is in operation and hard disk recordings may be made. This activity is carried out for the security of all our guests and staff
